Kerry then welcomed the new Committee and thanked Taffy for acting as the Returning Officer.

Kerry thanked Brian and Jeanette O'Keeffe who had stood down for all electronic changes and for their help.

Kerry thanked Life Member Karon Fuller for her input for the past 10 years as Carnival Director. He said Karon has been suffering ill health for some time and still managed to do the work involved.

\* Regarding the position of Carnival Director. Two applications have been received. Helen Little from Southport and Peter Bain from Wentworthville. John Stanford suggested the Carnival Director's position to have 2 subordinates Race & Data Entry Manager and Event Manager. After discussion took place it was agreed by all that the position of Carnival Director remains the same at this AGM. Moved by Brian O'Keeffe and seconded by Sean Henly. A ballot was held and Peter Bain was elected Carnival Director.

Sean read out a letter regarding Bellingens Constitution problems. After much discussion it was decided that the proposed Constitution dated (10<sup>th</sup> July) be withdrawn and John Stanford from Southport be appointed to rewrite the Constitution. All agreed. John stated he will commence a process seeking advice and input from all affiliated clubs from early October when clubs are functioning. Other consultation on an individual basis and with the Executive Committee will commence immediately. The Committee will then review for the next AGM.

Kerry Ryan spoke about helping to fund Nelson Bay as they ran at a loss due to an unexpected costing for seating and marquees at poolside at the 2013 AIF Carnival. The Treasurer stated we are in a good position to be able to help, especially as it is Nelson Bays second year in a row. It was decided to allocate Nelson Bay the sum of \$2.500.

Kerry added a proviso that we get a costing after the carnival and if any rebate we should get a share back. It was noted that it could be starting a precedent, however, this situation was not caused by the Nelson Bay club and it is considered the Association should assist in this particular instance.

Nelson Bay asked whether clubs are interested in pre-ordering/prepaying for shirts for the 2014 Carnival.

AIF carnivals coming up: 15<sup>th</sup> March 2014 at Nelson Bay; 2015 Albury; 2016 Southport are confirmed.

Mick Pearce asked if an Agenda could be sent out before the next Meeting. Jeanette O'Keeffe replied she had handed the Agenda out a little earlier that night.
